

RESOLUTION No. 217405Adopted on DEC 29 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to the Lease Agreement with the COUNTY OF SAN DIEGO, a political subdivision of the State of California, for the County's use of a portion of the fifth floor and a portion of the basement in the City Operations Building for a period ending November 8, 1979, with a six month extension option, and providing for an increase in rent of \$2,361.50 per month beginning January 17, 1977, as set forth in the form of First Amendment to Lease Agreement on file in the office of the City Clerk as Document No. 757765.
