

RESOLUTION NO. 217406

WHEREAS, the Productivity Improvement Project (herein called "Project") has as its goal increasing the efficiency and effectiveness of City operations by developing engineered work standards and a productivity performance reporting system; and

WHEREAS, the Project is currently in its third year of operation; and

WHEREAS, the Project has studied and is scheduled to study various City departments; and

WHEREAS, the Planning Department is not currently included in the Project Long Range Plan; and

WHEREAS, some concern has been registered that the Project should be modified to include a study of the Planning Department in the near future; and

WHEREAS, the Manager has submitted information and recommendations in this regard and has indicated the needs to accomplish that goal; and

WHEREAS, the Transportation and Land Use Committee considered said report and is recommending that the Council direct that a productivity improvement study of the Planning Department be initiated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to amend the Productivity Improvement Project schedule to initiate at an early date a productivity improvement study of the Planning Department.
