
Adopted on _____

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO CHAMBER OF COMMERCE to provide a comprehensive expanded update of their Economic Research Bureau's 1969 study program, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 757784.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to reduce the Program Development & Administration Budget Fund 290, Program Element 87.02, by \$50,000 of EDA 302 Planning Grant Federal Funds and making these funds available in Fund 280 for administration of the remaining Grant by the Engineering and Development Department.
