WHEREAS, an application for the transfer of 280 certificates of public convenience and necessity from SAN DIEGO YELLOW CABS, INC. to WESTERN STATES TRANSPORTATION, INC. to operate taxicabs within the limits of the City of San Diego has been received; and

WHEREAS, pursuant to Section 72.0101(h) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this City Council; and

WHEREAS, his report indicates, among other things, that the applicant, Western States Transportation, Inc., is a wholly owned subsidiary of Ocean Salt Co., Inc. whose president is Donald R. Swortwood, whose character and fitness recommend him to engage in the business of operating taxicabs; and

WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the transfer of 280 certificates of public convenience and necessity for taxicabs, as more particularly set forth above, be and it is hereby approved, subject to the following conditions precedent:

(1) That the transferee comply with all provisions of the San Diego Municipal Code.



(3) That the United States District Court for the Southern District of California, which has jurisdiction over the bankruptcy proceedings involving the Yellow Cab Company, approve the sale of the assets of San Diego Yellow Cabs, Inc. to Western States Transportation, Inc.
