WHEREAS, The City of San Diego has heretofore issued 280 certificates of public convenience and necessity to operate taxicabs to the Yellow Cab Company of San Diego; and

WHEREAS, this number of certificates is approximately 80% of the outstanding certificates of public convenience and necessity for taxicab service within the City of San Diego; and

WHEREAS, Yellow Cab Company of San Diego has indicated that it cannot operate taxicabs at the present time due to a lack of appropriate insurance coverage; and

WHEREAS, Section 72.0101(m) of the San Diego Municipal Code provides that certificates of public convenience and necessity may be issued to qualified persons which are limited in duration of time; and

WHEREAS, an emergency exists concerning taxicab service in the City of San Diego at the present time; and

WHEREAS, the applicant, MICHAEL LAWRENCE MARGUET, has submitted data to the City Manager sufficient to comply with Section 72.0101(a) through (1) of the San Diego Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Michael Lawrence Marguet be and he is hereby authorized to operate a taxicab under one (1) limited certificate of public convenience and necessity for a period not to exceed 30 days from
