WHEREAS, an emergency exists concerning taxicab service in the City of San Diego at the present time; and

whereas, the applicant, MICHAEL LAWRENCE MARGUET, has submitted data to the City Manager sufficient to comply with Section 72.0101(a) through (1) of the San Diego Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Michael Lawrence Marguet be and he is hereby authorized to operate a taxicab under one (1) limited certificate of public convenience and necessity for a period not to exceed 30 days from
