

ORDINANCE NO. 11068 MAY 24 1973  
(New Series)

AN ORDINANCE INCORPORATING LOT 4 AND A PORTION OF LOT 3, SOUTH SAN DIEGO HEIGHTS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 8029 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Lot 4 and a portion of Lot 3, South San Diego Heights, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. B-2691, filed in the office of the City Clerk under Document No. 743292 be, and they are hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8029 (New Series), adopted December 18, 1958 of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
