AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 1335, 1336, 1338, 1339, 1340, AND 1362: AND A PORTION OF SECTION 25, TOWNSHIP 14 SOUTH, RANGE 4 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE, AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, ORDINANCE NO. 13455 APPROVED FEBRUARY 15, 1932, AND ORDINANCE NO. 5591 (NEW SERIES), ADOPTED MAY 19, 1953 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That portions of Pueblo Lots 1335, 1336, 1338, 1339, 1340, and 1362; and a portion of Section 25, Township 14 South, Range 4 West, S.B.B.M., in the City of San Diego, California, within the boundary of the district designated "A-1-10" on Zone Map Drawing No. C-377.3, filed in the office of the City Clerk under Document No. 743345 be, and they are hereby incorporated into A-1-10 Zone, as such zone is described and defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10936 (New Series), adopted October 5, 1972, Ordinance No. 13455 approved February 15, 1932, and Ordinance No. 5591 (New Series), adopted May 19, 1953, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.


