AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 84.11 RELATING TO CLINGING TO MOVING VEHICLES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 4, of the San Diego Municipal Code be and the same is hereby amended by repealing the following section:

SEC. 84.11 CLINGING TO MOVING VEHICLES

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
