AN ORDINANCE AMENDING ORDINANCE NO. 11872 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR."

WHEREAS, the annual appropriation ordinance for fiscal year 1975-76, Ordinance No. 11650 (New Series), as amended, was amended to add a subsection 39 to Section 2 to provide for a Deferred Compensation Plan Fund and a subsection 40 to Section 2 to provide for Community Development Block Grant Funds; and

WHEREAS, the annual appropriation ordinance for fiscal year 1976-77, Ordinance No. 11872 (New Series), as amended, inadvertently omitted said subsections; and

WHEREAS, it is now desirable and necessary to correct said omissions by adding to the annual appropriation ordinance those subsections and language relating to said areas; and

WHEREAS, it is further necessary at this time to amend subsection 40 of Section 2 to provide for an updated authorization of Community Development Block Grant Funds for calendar year 1977; and

WHEREAS, on September 1, 1976, the City Council approved submission of the Third Year Community Development Block Grant (CDBG) application (for calendar year 1977) and authorized the City Manager to execute the grant agreement; and

MICROFILMED MAY 1 5 1978 WHEREAS, the City has been advised that the application should be processed and approved prior to December 10, 1976 so that the City Manager may execute said agreement; and

WHEREAS, the Third Year CDBG application is in the amount of \$10,511,000; and

WHEREAS, the CDBG program is an ongoing operation for which funding should be continuous; and

WHEREAS, the Second Year Block Grant programs were included in the 1975-76 annual appropriation ordinance on a calendar year basis ending December 31, 1976; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to reflect the approval and inclusion of Third Year Grant programs and accompanying funds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11872 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Section 2 thereof by adding subsection 39, entitled "DEFERRED COMPENSATION PLAN FUND," and subsection 40, entitled "COMMUNITY DEVELOPMENT."

BLOCK GRANT FUNDS, " to read as follows:

Section 2. There is hereby appropriated for expenditure out of the several funds of said City for municipal purposes the following amounts:

39. DEFERRED COMPENSATION PLAN FUND

All funds generated from amounts being deferred from salaries and wages of officers and employees of The City of San Diego participating in a Deferred Compensation Plan, and all earnings thereon, shall be deposited in a Deferred Compensation Plan Fund established by the Auditor and Comptroller for custodial and disbursement purposes. The Auditor and Comptroller is authorized to appropriate from said fund sufficient monies as may be necessary to pay participant investment fees. The Deferred Compensation Plan Fund is appropriated to provide funds for obligations incurred pursuant to the Deferred Compensation Plans to be disbursed in accordance with provisions of said plans as authorized by the City Council.

40. COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

Community Development Block Grant Funds are appropriated for the purposes established by the grant provisions as approved and authorized by the City Council. All authorized but uncompleted program activities and unexpended monies related thereto remaining in the Community Development Block Grant Fund on December 31, 1976 shall be carried forward to future years for the purpose of completing said authorized activities.

Section 2. That this Council hereby approves and adopts the Program Budget for the Program Development and Administration Division, City Manager's Department (Activity 86.00) for calendar

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
