AN ORDINANCE AMENDING ORDINANCE NO. 11845 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1976-77," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITION OF DISPUTE RESOLUTION OFFICER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 11845 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1976-77," is hereby amended to create and establish the classified position of Dispute Resolution Officer.

Section 2. As a schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Pay for Standard Rates established and adopted by Ordinance No. 11845 (New Series), as amended, of the ordinances of said City, is hereby adopted.

Section 3. The position of Dispute Resolution Officer shall be inserted in Exhibit B of Ordinance No. 11845 (New Series), as amended, under the general category of FIELD CONTACT, between the positions of Customer Services Supervisor and Supervising Sanitation Inspector.


