AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 10939 \*NEW SERIES), ADOPTED OCTOBER 12, 1972, AMENDED BY ORDINANCE NO. 11481 (NEW SERIES), ADOPTED JANUARY 23, 1975, AMENDED BY ORDINANCE NO. 11743 (NEW SERIES), ADOPTED DECEMBER 24, 1975, AMENDED BY ORDINANCE NO. 11855 (NEW SERIES), ADOPTED JUNE 23, 1976, INCORPORATING A PORTION OF THE SOUTHEAST 1/4 OF SECTION 27, TOWNSHIP 18 SOUTH, RANGE 2 WEST, SBBM, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE.
