AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING RULE 17.1 TO SECTION 22.0101 RELATING TO APPEALS TO COMMITTEES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Division 1, of the San Diego Municipal Code be amended by adding Rule 17.1 to Section 22.0101 to read as follows:

Rule 17.1 Special Rule with respect to Appeals to Committees

Sections 33.0502, 35.0110, 57.01.7, 62.0413, 72.0216(g) and 102.0221, paragraph 7 provide for appeals to the Committees of the Council established by these Rules. Upon a decision being rendered on appeal, the Chairman of the Committee shall advise all interested persons of the provisions of Rule 4 hereof. Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
