AN ORDINANCE AMENDING ORDINANCE NO. 11845 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1976-77," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITIONS OF HOUSING ASSISTANT II AND HOUSING ASSISTANT I, AND ESTABLISH A SCHEDULE OF COMPENSATION FOR SAID POSITIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 11845 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1976-77," is hereby amended to create and establish the classified positions of Housing Assistant II and Housing Assistant I.

Section 2. As a schedule of compensation for the positions created in Section 1 hereof, the following standard rate numbers of the Table of Pay for Standard Rates established and adopted by Ordinance No. 11845 (New Series), as amended, of the ordinances of said City, are hereby adopted.


