SEC. 42.0713 SPECIAL PERMITS

Special permits may be granted for the maintenance of animals and poultry not in strict conformity with the provisions of this Division, if the Director of Public Health makes a finding that because of soil, drainage, prevailing winds, absence of insect life, unusually effective sanitation measures, population density in the area, innocuousness of the animal or poultry involved, or like conditions, the public health and welfare will not be endangered thereby and such animals or poultry shall be kept in a manner consistent with the conditions, if any, imposed in such special permit and within the scope thereof.
