AN ORDINANCE AMENDING ORDINANCE NO. 11872 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 754397, AS ADOPTED AND AMENDED THEREIN, RELATING TO TRANSFER OF THE RELOCATION ELEMENT (39.52) OF THE REDEVELOPMENT PROGRAM, AND PERSONNEL AND FUNDS ASSOCIATED THEREWITH, FROM THE ENGINEERING AND DEVELOPMENT DEPARTMENT TO THE HUMAN RESOURCES DEPARTMENT (05.00); AMENDING THE TITLE OF THE HUMAN RESOURCES DEPARTMENT TO READ "HOUSING AND COMMUNITY SERVICES DEPARTMENT"; AND AUTHORIZING THE CITY MANAGER AND THE CITY AUDITOR AND COMPTROLLER TO MAKE ALL NECESSARY BUDGETARY AND PROGRAM ADJUSTMENTS TO EFFECT SAID TRANSFER.

WHEREAS, the City Manager has submitted a proposal for an administrative reorganization in order to consolidate all housing-related functions in one department; and

WHEREAS, the annual appropriation ordinance has assigned the function of Housing Coordination and Relocation to the Engineering and Development Department; and

WHEREAS, it is now desirable and necessary to amend said ordinance to reassign those functions and associated personnel assigned to the Engineering and Development Department to the Human Resources Department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11872 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY

TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 754397, as adopted and amended therein, to amend that portion of the Position and Salary Schedule and Operating Program Summary for Fund 100, Department 39.00, Engineering and Development, by transferring therefrom the Relocation Element (39.52) and the Housing Coordination function of the Redevelopment Program and associated personnel and funds to the Human Resources Department (05.00).

Section 2. That the annual budget, as reflected in Document No. 754397, as amended, be further amended to change the title of the Human Resources Department (05.00), as reflected on pages 90 through 113 of Volume I of said budget, to read "Housing and Community Services Department."

Section 3. That the City Manager and the City Auditor and Comptroller be and they are hereby fully authorized to make all budgetary and program adjustments necessary to effect said transfer of function and personnel.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
