AN ORDINANCE AMENDING CHAPTER V, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 56.54 PROHIBITING CONSUMPTION OF ALCOHOLIC BEVERAGES IN CERTAIN AREAS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 6, of the San Diego Municipal Code be and the same is hereby amended by adding Section 56.54 to read as follows:

SEC. 56.54 ALCOHOLIC BEVERAGE CONSUMPTION PROHIBITED IN CERTAIN AREAS

It shall be unlawful for any person without a permit duly issued by the City Manager for a special event to consume any alcoholic beverage, as defined in California Business and Professions Code Section 23004, upon any public street, sidewalk, alley, plaza, or in any public park within the following limits of the City of San Diego:

Starting at the intersection of Market Street and Pacific Highway and proceeding northerly on Pacific Highway to its intersection with Ash Street; then easterly on Ash Street to its intersection with llth Avenue; then southerly on 11th Avenue to its intersection with "A" Street; then easterly on "A" Street to its intersection with 12th Avenue; then southerly on 12th Avenue to its intersection with Imperial Avenue; when westerly on Imperial Avenue to the Atchison, Topeka and Santa Fe Railroad; then westerly along the Atchison, Topeka and Santa Fe Railroad to its intersection with Union Street; then northerly on Union Street to its intersection with Market Street; and then westerly on Market Street to the point of beginning.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
