That the Auditor and Comptroller be and he is hereby fully authorized to transfer within the General Fund 100 the sum of \$10,800 from the Unallocated Reserve (53.31) to the City Council Departments as follows: District 6 (02.06)-\$5,400; District 7 (02.07)-\$5,400; to be used solely and exclusively for the above purpose.
