AN ORDINANCE AMENDING ORDINANCE NO. 11872 (NEW SERIES), AS AMENDED, ENTITLED- "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 754397, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE DEPARTMENTS OF CITY COUNCIL-DISTRICT 6 (02.06) AND DISTRICT 7 (02.07) BY ADDING ONE COUNCIL REPRESENTATIVE POSITION TO EACH DEPARTMENT AND PROVIDING SUFFICIENT FUNDS FOR PERSONNEL SERVICES FOR THOSE POSITIONS FOR REMAINDER OF FISCAL YEAR 1977.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11872 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 754397, as adopted and amended therein, to amend that portion of the Position and Salary Schedule and Operating Program Summary for Fund 100, Department 02.06, City Council-District 6, and Department 02.07, City Council-District 7, by adding one (1) Council Representative position to each of the enumerated departments.

Section 2. That the Auditor and Comptroller be and he is hereby fully authorized to transfer within the General Fund 100 the sum of \$10,800 from the Unallocated Reserve (53.31) to the City Council Departments as follows: District 6 (02.06)-\$5,400; District 7 (02.07)-\$5,400; to be used solely and exclusively for the above purpose.


