ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF MAMMOTH DRIVE AND ITS SOUTHERLY EXTENSION AND WEST OF MISSION VILLAGE DRIVE, AND BETWEEN RONDA AVENUE ON THE NORTH AND FRIARS ROAD ON THE SOUTH, IN THE SERRA MESA COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides east of Mammoth Drive and its southerly extension and west of Mission Village Drive, and between Ronda Avenue on the north and Friars Road on the south, in the Serra Mesa Community Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-517, filed in the office of the City Clerk as Document No. 758042, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
