AN ORDINANCE INCORPORATING A PORTION OF PUEBLO LOT 256, RECORD OF SURVEY 837, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CS ZONE, AS DEFINED BY SECTION 101.0432 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 2009 (NEW SERIES), ADOPTED DECEMBER 10, 1940, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map or maps is recorded on a portion of Pueblo Lot 256, Record of Survey 837, in the City of San Diego, California, within the boundary of the district designated "CS" on Zone Map Drawing No. B-2956, the provisions of Section 101.0432 of the San Diego Municipal Code shall attach and become applicable to the said land and shall be incorporated into CS Zone, as described and defined by Section 101.0432, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2956, filed in the office of the City Clerk as Document No. 758068.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 2009 (New Series), adopted December 10, 1940, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the
