AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 22.0226 ESTABLISHING CONSULTANT LIMITATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Division 2, of the San Diego Municipal Code be and it is hereby amended by adding Section 22.0226 to read as follows:

SEC. 22.0226 CONSULTANT LIMITATIONS

In connection with the provisions of Section 28 of the Charter of The City of San Diego, the City Manager, except as otherwise provided by Charter or ordinance, shall have the power to employ experts or consultants to perform work or give advice connected with departments of the City without first seeking Council approval provided the cost of such employment does not exceed ten thousand dollars (\$10,000). However, if the total compensation paid to an expert or consultant exceeds \$10,000 during a twelve-month period, Council approval must be obtained.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
