ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING DEL MAR VILLAS LOCATED BETWEEN PORTOFINO DRIVE ON THE WEST AND I-5 ON THE EAST, AND BETWEEN DEL MAR HEIGHTS ROAD ON THE NORTH AND CARMEL VALLEY ROAD ON THE SOUTH, IN THE TORREY PINES COMMUNITY PLANNING AREA, IN THE CITY OF SAN-DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10126 (NEW SERIES), ADOPTED SEPTEMBER 4, 1969, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Del Mar Villas, located between Portofino Section 1. Drive on the west and I-5 on the east, and between Del Mar Heights Road on the north and Carmel Valley Road on the south, in the Torrey Pines Community Planning Area, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. C-464.1, filed in the office of the City Clerk as Document No. 758211, be, and it is hereby incorporated into R-1-5 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

That Ordinance No. 10126 (New Series), adopted Section 2. September 4, 1969, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall-take effect and be force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
