AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 11440 (NEW SERIES), ADOPTED NOVEMBER 27, 1974, INCORPORATING LOTS 3-6, BLOCK 26, ROSE-VILLE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1S ZONE, AS DEFINED BY SECTION 101.0430 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 11440 (New Series), adopted November 27, 1974; and

WHEREAS, Ordinance No. 11440 (New Series) provided that the C-1S Zone would attach on the subject property if a parcel map or maps were recorded on or before December 27, 1976; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 11440 (New Series), adopted November 27, 1974, be, and it is hereby amended to read as follows:

Section 1. That in the event that, on or before

December 27, 1977, a parcel map or maps for lot

consolidation are recorded on Lots 3-6, Block 26,

Roseville, in the City of San Diego, California,

designated "C-15" on Zone Map Drawing No. B-2819, OCT 41978

the provisions of Section 101.0430 of the San

Diego Municipal Code shall attach and

become applicable to the land and said land shall be incorporated into C-IS Zone, as described by Section 101.0430, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2819, filed in the office of the City Clerk as Document No. 749037. Said zoning shall attach only to those areas included in the parcel map or maps as provided in this section. Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
