AN ORDINANCE AMENDING ORDINANCE NO. 11872 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1976-77 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 754397, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE CITY TREASURER'S DEPARTMENT (07.10) BY ADDING ONE ASSOCIATE ADMINISTRATIVE ANALYST POSITION TO THE CITY TREASURER FOR THE PURPOSE OF ADMINISTERING THE INVESTMENT EARNINGS MAXIMIZATION PROGRAM.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Treasurer, by adding one (1) Associate Administrative Analyst position to perform as an Investment Officer.
