AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 2,
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE
BY AMENDING SECTION 72.0110 RELATING TO
PUBLIC LIABILITY FOR TAXICABS.

Section 1. That Chapter VII, Article 2, Division 1
of the San Diego Municipal Code be and it is hereby amended
by amending Section 72.0110 to read as follows:

SEC. 72.0110 PUBLIC LIABILITY

It shall be unlawful to operate a taxicab unless
there shall be filed with The City of San Diego, a
policy of insurance executed and delivered by a company
authorized to carry on an insurance business in the
State of California, the financial responsibility of
which company shall theretofore have been approved by
the City Manager, by the terms of which said insurance
company assumes responsibility for injuries to persons
or property caused by the operation of said vehicle in
the minimum amounts set from time to time by resolution
of the City Council.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.


