AN ORDINANCE INCORPORATING A PORTION OF LOT A-245, ADDITION TO SAN YSIDRO, AND LOT 7, CORDEAU SUBDIVISION, LOCATED ON THE EAST AND WEST SIDES OF AVERIL ROAD BETWEEN SUNSET LANE AND BLACKSHAW LANE, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, INSOFAR AS THE SAME CONFLICTS HEREWITH

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot A-245, Addition to
San Ysidro, and Lot 7, Cordeau Subdivision, located on the
east and west sides of Averil Road between Sunset Lane and
Blackshaw Lane, in the San Ysidro Community Plan area, in
the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. B-2950.2,
filed in the office of the City Clerk as Document No. 758914
be, and it is hereby incorporated into R-2 Zone, as such
zone is described and defined by Section 101.0409 of the San Diego
Municipal Code.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
