AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 3 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 63.20.16 (PARAGRAPH (b), SUBPARAGRAPH (4)) RELATING TO REGULATIONS FOR FISHING PIERS OWNED OR OPERATED BY THE CITY OF SAN DIEGO.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 3 of the San Diego Municipal Code be amended by amending Section 63.20.16 to read as follows:

SEC. 63.20.16 FISHING PIERS OWNED OR OPERATED BY THE CITY OF SAN DIEGO--REGULATIONS

(a) [No amendment to this paragraph.]

(b) It shall be unlawful for any person to perform any of the following acts on any fishing pier owned or operated by The City of San Diego:

(1) through (3) [No amendment to these subparagraphs.]

(4) Swim, wade, surf, or skin dive within seventy-five feet (75') of the pier.

(5) through (15) [No amendment to these subparagraphs.]

(c) and (d) [No amendment to these paragraphs.]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


