AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF BALBOA PARK AND WEST OF COMMONWEALTH AVENUE, AND BETWEEN OLIVE STREET ON THE NORTH AND DATE STREET ON THE SOUTH IN AREA A-BALBOA PARK EAST, AND THOSE HILLSIDES EAST OF TEXAS STREET AND WEST OF THE NORTHERLY EXTENSION OF UVADA PLACE, AND BETWEEN CAMINO DEL RIO SOUTH ON THE NORTH AND ADAMS AVENUE ON THE SOUTH IN AREA B-TEXAS STREET, ALL IN THE PARK NORTHEAST COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides east of Balboa Park and west of Commonwealth Avenue, and between Olive Street on the north and Date Street on the south in Area A-Balboa Park East, and those hillsides east of Texas Street and west of the northerly extension of Uvada Place, and between Camino Del Rio South on the north and Adams Avenue on the south in Area B-Texas Street, all in the Park Northeast Community Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-525, filed in the office of the City Clerk as Document No. 758562, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
