AN ORDINANCE AMENDING CHAPTER IV, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 44.0302 AND 44.0303 RELATING TO SPECIAL PERMITS FOR MAINTENANCE OF ANIMALS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IV, Article 4, of the San Diego Municipal Code be and the same is hereby amended by amending Sections 44.0302 and 44.0303, to read as follows:

SEC. 44.0302 SPECIAL PERMITS

Special permits may be granted for the maintenance of animals not in strict conformity with the provisions of this Division, if the Director of Public Health makes a finding that because of soil, drainage, prevailing winds, absence of insect life, unusually effective sanitation measures, population density in the area, innocuousness of the animal or animals involved, or like conditions, the public health and welfare will not be endangered thereby and such animals shall be kept in a manner consistent with the conditions, if any, imposed in such special permit and within the scope thereof.

SEC. 44.0303 DENIAL AND REVOCATION OF PERMITS

Permits for the maintenance of animals may be denied or revoked in whole or in part or conditionally by the Director of Public Health upon his finding that because

MICROFILMED oct 4 1978 of any of the conditions mentioned in the preceding section or because of the ineffectiveness of sanitation measures or a particular or peculiar hazard connected with the animal or animals involved, the public health and welfare will be endangered, unless such action is taken.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
