AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 1,  
DIVISION 1, OF THE SAN DIEGO MUNICIPAL CODE  
BY AMENDING SECTION 71.0101(g) RELATING TO  
VEHICLES FOR HIRE.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:


Section 1. That Chapter VII, Article 1, Division 1, of  
the San Diego Municipal Code be and it is hereby amended by  
amending Section 71.0101(g), to read as follows:

SEC. 71.0101 DEFINITIONS

(g) "Automobile for Hire" shall mean every auto-  
mobile or motor-propelled vehicle, other than a taxicab,  
sightseeing-vehicle or vehicles involved in an organized  
car pool which is not available to the general public,  
which is operated by its owner or an employee, agent or  
representative of the owner for any fare or consideration,  
and used for the transportation of passengers over the  
public streets of the City of San Diego, irrespective of  
whether such operations extend beyond the boundary limits  
of said City.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.


