AN ORDINANCE INCORPORATING PORTIONS OF LOTS 1 AND 2 AND ALL OF LOT 22, BLOCK 26, ROSEVILLE SUBDIVISION, LOCATED ON SCOTT STREET BETWEEN SHELTER ISLAND DRIVE AND CARLETON STREET AND ON CARLETON STREET BETWEEN SCOTT STREET AND SHAFTER STREET, IN THE PENINSULA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 32 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, portions of Lots 1 and 2 and all of Lot 22, Block 26, Roseville Subdivision, located on Scott Street between Shelter Island Drive and Carleton Street and on Carleton Street between Scott Street and Shafter Street, in the Peninsula Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "C-1" on Zone Map Drawing No. B-2978, is the subject of which a parcel map or maps is submitted to the City and thereafter recorded, and provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0430.1 of the San Diego Municipal Code shall attach and become applicable to said land, and said land shall be incorporated into C-1 Zone, as described and defined by Section 101.0430.1, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2978, filed in the office of the City Clerk as Document No. 759399. Said zoning shall attach only to those areas

included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 32 (New Series), adopted September 6, 1932, of the ordinances of The City of San Diego, be, and the same is hereby repealed insofal as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this \_\_\_\_\_\_\_\_.
