AN ORDINANCE CALLING A MUNICIPAL PRIMARY ELECTION IN THE CITY OF SAN DIEGO, IN THE SAN DIEGO UNIFIED SCHOOL DISTRICT, AND IN THE SAN DIEGO COMMUNITY COLLEGE DISTRICT, ON TUESDAY, SEPTEMBER 20, 1977.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 4. For the purpose of said elections, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain of said precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the office of the City Clerk.

Section 5. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for said elections.

Section 6. That the polls for said elections shall be open from 7:00 a.m. until 8:00 p.m. on Tuesday, September 20, 1977.

Section 7. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment, supplies and other printed matter.

Section 8. The following rates of compensation are hereby established for said election:
