ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING THOSE HILLSIDES IN SECTION 7, TOWNSHIP 14 SOUTH, RANGE 2 WEST; SECTION 13, TOWNSHIP 14 SOUTH, RANGE 3 WEST; AND THOSE HILLSIDES EAST OF SECTION 13, TOWNSHIP 14 SOUTH, RANGE 3 WEST AND WEST OF I-15, AND BETWEEN THE NORTHERLY BOUNDARY OF RANCHO DE LOS PENASQUITOS ON THE NORTH AND TWIN TRAILS DRIVE, BLACK MOUNTAIN ROAD, AND CARMEL MOUNTAIN ROAD ON THE SOUTH, ALL IN THE PENASQUITOS COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides in Section 7, Township 14 South, Range 2 West; Section 13, Township 14 South, Range 3 West; and those hillsides east of Section 13, Township 14 South, Range 3 West and west of I-15, and between the northerly boundary of Rancho de los Penasquitos on the north and Twin Trails Drive, Black Mountain Road, and Carmel Mountain Road on the south, all in the Penasquitos Community Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-527, filed in the office of the City Clerk as Document No. 759478, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
