AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT FOR THE CONSTRUCTION AND OPERATION OF SWIMMING FACILITIES AT CLAIREMONT AND ALLIED GARDENS PARK AND RECREATION CENTERS, UNDER THE TERMS AND CONDITIONS OF THE AGREEMENT ON FILE IN THE OFFICE OF THE CITY CLERK'S OFFICE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute a lease agreement with The SAN DIEGO UNIFIED SCHOOL DISTRICT for the construction and operation of swimming facilities at CLAIREMONT AND ALLIED GARDENS PARK AND RECREATION CENTERS, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 759695.

Section 2. That the requirements of Municipal Code Section 22.0901 subsection (c) and (d) relating to independent fee appraisals and the filing of lease forms with the City Clerk for 30 days prior to Council action shall not be applicable to these leases.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
