AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT, WHEREBY CITY LEASES FROM THE DISTRICT FOURTEEN SCHOOL DISTRICT PROPERTIES UNDER THE TERMS AND CONDITIONS OF THE LEASE AGREEMENT ON FILE WITH THE CITY CLERK'S OFFICE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute a lease agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT whereby City leases from the District the following fourteen School District Properties:
