AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT, WHEREBY CITY LEASES FROM THE DISTRICT TEN SCHOOL PROPERTIES, UNDER THE TERMS AND CONDITIONS OF THE LEASE AGREEMENT ON FILE WITH THE CITY CLERK'S OFFICE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute a lease agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT which lease is for a 25 year term and provides for construction, maintenance and operation of lighted playground facilities at the following ten school district properties:

- Field Elementary
- 2. Cabrillo Playground
- 7. Forward Elementary
- 3. Birney Elementary
- 8. Pacific Beach Junior High
- 4. Ocean Beach Elementary
- 9. Lewis Junior High
- 5. Kennedy Elementary
- 10. Marston Junior High

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
