AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT, WHEREBY CITY LEASES FROM THE DISTRICT FACILITIES AT STOCKTON ELEMENTARY SCHOOL, UNDER THE TERMS AND CONDITIONS OF THE LEASE AGREEMENT ON FILE WITH THE CITY CLERK'S OFFICE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute a lease agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT which lease is for a 25 year term and provides for construction maintenance and operation of fieldhouse and lighted recreational facilities at the STOCKTON ELEMENTARY SCHOOL, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 760409

Section 2. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
