
AN ORDINANCE INCORPORATING THOSE HILLSIDES IN SECTIONS 32 AND 33, TOWNSHIP 13 SOUTH, RANGE 2 WEST; AND SECTIONS 4 AND 5, TOWNSHIP 14 SOUTH, RANGE 2 WEST, IN THE PENASQUITOS COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. Those hillsides in Sections 32 and 33, Township 12 South, Range 2 West; and Sections 4 and 5, Township 14 South, Range 2 West, in the Penasquitos Community Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-526, filed in the office of the City Clerk as Document No. 759477, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
