BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter V, Article 6, of the San Diego  
Municipal Code be and the same is hereby amended by repealing  
the following sections:

SEC. 56.25 INTOXICATION IN PUBLIC PLACE--PROHIBITED

SEC. 56.26 ~~INTOXICATION ON PRIVATE PREMISES--PROHIBITED~~

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage
