Section 1. That Chapter V, Article 6, of the San Diego Municipal Code be and the same is hereby amended by repealing the following sections:

SEC. 56.25 INTOXICATION IN PUBLIC PLACE--PROHIBITED

SEC. 56.26—INTOXICATION ON PRIVATE PREMISES--PROHIBITED

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage
