AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 92.0605(A.), RELATING TO WIRING METHODS

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 92.0605(A.), to read as follows:

SEC. 92.0605 WIRING METHODS

A. Article 336-3 is amended as follows: Nonmetallic wiring methods may be used only in residential-accessor buildings and residential buildings having not more than three floors above grade.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
