AN ORDINANCE WAIVING PROVISIONS OF MUNICIPAL CODE SECTION 22.0901 WITH REGARD TO THE REQUIREMENTS OF INDEPENDENT FEE APPRAISALS, AND 30 DAY FILING PERIOD WITH CLERK'S OFFICE WITH REGARD TO TWO SAN PASQUAL AGRICULTURAL LEASES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That with regard to City Leases to BERT VERGER, dba BERT VERGER DAIRY, and ROY L. BYRNES dba THE BYRNES RANCH, which leases were approved by Resolutions Nos. 218962 and 218961, respectively, the requirements of subsection (c) and (d) of Municipal Code Section 22.0901 pertaining to the necessity of an independent fee appraisal and the necessity of filing lease forms with the City Clerk, 30 days prior to Council action, are hereby waived.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
