AN ORDINANCE AMENDING CHAPTER II, ARTICLE 4, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING TO DIVISION 9 THEREOF A NEW SECTION 24.0901.1, ENTITLED MEETINGS; QUORUM.

WHEREAS, the subject of changing voting requirements of the Retirement Board (herein called "Board") for meetings and hearings was recommended to and discussed by the Rules Committee; and

WHEREAS, the Rules Committee approved on May 9, 1977, a change to said voting requirements to require a majority of said Board to act affirmatively in order to take any final action; and

whereas, the Rules Committee directed said change be forwarded to the full Council for inclusion of said requirement
into the Municipal Code of The City of San Diego, NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 4, of the San Diego Municipal Code be and the same is hereby amended by adding to Division 9 thereof Section 24.0901.1 to read as follows:

SEC. 24.0901.1 MEETINGS; QUORUM

Nine (9) of the members elected and appointed to the Board pursuant to Section 144 of the Charter shall constitute a quorum to do business or conduct a hearing but a lesser number may take action to adjourn a meeting or hearing from time to time. The affirmative vote

of a majority of the members elected and appointed to the Board shall be necessary to pass any vote and take final action on any decision before the Board except that a vote to adjourn may be adopted by a majority of the members present.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
