AN ORDINANCE INCORPORATING A PORTION OF LOT 1, NICHOL'S RIDGE, AND PORTIONS OF LOTS 2 AND 5, NEW RIVERSIDE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA and M-1B ZONES, AS DEFINED BY SECTIONS 101.0428.1 AND 101.0435.2, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NOS. 8385 (NEW SERIES), ADOPTED NOVEMBER 10, 1960, AND 11113 (NEW SERIES), ADOPTED SEPTEMBER 6, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, a portion of Lot 1, Nichol's Ridge, and portions of Lots 2 and 5, New Riverside, in the City of San Diego, California, designated "CA" and "M-1B" on Zone Map Drawing No. B-2991 is subdivided and a final subdivision map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0428.1 and 101.0435.2, respectively, of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land-shallbe incorporated into CA and M-1B Zones, as described and defined by Sections 101.0428.1 and 101.0435.2, respectively, the boundary of such zones to be as indicated on Zone Map Drawing No. B-2991, filed in the office of the City Clerk as Document No. 760641. Said zoning shall attach only to those areas included in the subdivision map or maps as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance Nos. 8385 (New Series), adopted November 10, 1960, and 11113 (New Series), adopted September 6, 1973, of the ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
