AN ORDINANCE AMENDING CHAPTER V, ARTICLE 5,
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING
SECTION 55.10.105(a), RELATING TO FIRE
PREVENTION AND PROTECTION.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter V, Article 5, of the San Diego
Municipal Code be and the same is hereby amended by adding
Section 55.10.105(a), to read as follows:

SEC. 55.10.105 SEC. 10.105(a) OF THE 1973 UNIFORM
FIRE CODE AMENDED

Section 10.105(a) General. For the purposes of
this section the term "corridor" shall include "exterior
exit balcony" and any covered or enclosed exit passage-
ways including walkways, tunnels and malls. Foyers,
lobbies and reception rooms meeting construction require-
ments as specified in the Building Code may be classed
as corridors.

Partitions, rails, counters, and similar space
dividers not over sixty-nine (69) inches in height
above the floor, shall not be construed to form
corridors.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.


