AN ORDINANCE PREZONING PORTIONS OF LOTS 64 AND 65, RANCHO MISSION OF SAN DIEGO, S.C.C. 348 (TANNER-SAMPO ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA INTO R-1-40 ZONE AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Lots 64 and 65, Rancho Mission of San Diego, S.C.C. 348 (Tanner-Sampo Annexation), in the County of San Diego, California, within the boundary of the district designated "R-1-40" on that certain Zone Map Drawing No. B-2997, filed in the office of the City Clerk under Document-No. 760777, be, upon annexation to The City of San Diego, incorporated into R-1-40 Zone as defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of Tanner-Sampo Annexation, whichever is later.
