AN ORDINANCE INCORPORATING A PORTION OF SECTION 13, TOWNSHIP 14 SOUTH, RANGE 4 WEST, S.B.B.M., GENERALLY BOUNDED BY THE CITY OF DEL MAR ON THE WEST, BY SECTION 12, TOWNSHIP 14 SOUTH, RANGE 4 WEST ON THE NORTH, I-5 ON THE EAST, AND MANGO WAY ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-20 AND R-1-40 ZONES, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9026 (NEW SERIES), ADOPTED MAY 28, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Section 13, Township 14 South, Range 4 West, S.B.B.M., generally bounded by the City of Del Mar on the west, by Section 12, Township 14 South, Range 4 West on .. the north, I-5 on the east, and Mango Way on the south, in the City of San Diego, California, within the boundary of the district designated "R-1-20" and "R-1-40" on Zone Map Drawing No. C-464.2, be, and it is hereby incorporated into R-1-20 and R-1-40 Zones, as such zones are described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9026 (New Series), adopted May 28, 1964, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the

provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
