AN ORDINANCE INCORPORATING A PORTION OF SECTION 24, TOWNSHIP 14 SOUTH, RANGE 4 WEST, S.B.B.M., GENERALLY BOUNDED BY CORDERO ROAD ON THE NORTH, RECUERDO DRIVE ON THE EAST, THE SOUTHERN BOUNDARY OF DEL MAR HEIGHTS SUBDIVISION ON THE SOUTH, AND DURANGO DRIVE ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-15 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9026 (NEW SERIES), ADOPTED MAY 28, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INsofar AS IT CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Section 24, Township 14 South, Range 4 West, S.B.B.M., generally bounded by Cordero Road on the north, Recuerdo Drive on the east, the southern boundary of Del Mar Heights Subdivision on the south, and Durango Drive on the west, in the City of San Diego, California, within the boundary of the district designated "R-1-15" on Zone Map No. C-464.2, be, and it is hereby incorporated into R-1-15 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9026 (New Series), adopted May 28, 1964, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
