BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 12078 (New Series) entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1977-78," is hereby amended by amending Exhibit C, thereto within classification range of Executive II to change the title of Employee Services Director to read Risk Management Director.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


